Position Summary

The Dotte Mobile Grocer Driver will be the primary driver for Cultivate KC's newest Food Access collaboration. The Dotte Mobile Grocer is a retrofitted 2006 M2 Freightliner beverage truck that has been turned into a grocery store on wheels. Fit with storage, refrigeration, and freezers, the program works to bring food to neighborhoods of Wyandotte County where fresh food isn't abundantly available. You will work alongside the Mobile Market Community Council, a group of dedicated volunteers from Wyandotte County who have previously managed the vehicle.

Essential Functions & Responsibilities

- Drive the Dotte Mobile Grocer vehicle to participating community locations.
- Ensure the vehicle is appropriately stocked with grocery items before each distribution day.
- Arrive at community locations on time.
- Ensure appropriate setup and breakdown at each site.
- Work alongside the Dotte Mobile Grocer Specialist to manage volunteers at distribution sites.
- Work alongside the Dotte Mobile Grocer Specialist and the MMCC (Mobile Market Community Council) to insure proper and regular vehicle maintenance.

Placement Criteria

- **Possession of a CDL Class A or B driver's license is required.**
- Knowledge of Wyandotte County's history and community is preferred but not required;
- Experience with cross-cultural communication or working with non-native English speakers is preferred but not required;
- Knowledge of federal nutrition programs, such as SNAP (Supplemental Nutritional Assistance Program) and WIC (Women, Infant, Children) or a willingness to learn about these programs;
- Demonstrated organization, facilitation, communication, and presentation skills;
- Strong customer service skills and the ability to interact and communicate effectively and professionally with others;
- Experience in retail or grocery settings and the willingness to learn the company's POS (point of sale) system.

Physical Demands

This position requires typical physical demands for grocery work, such as walking, standing, reaching, squatting, lifting up to 50lbs and working outdoors year-round.

Work Location

This position will take place predominately on the Dotte Mobile Grocer, but Cultivate KC maintains office space at the Westport Commons Plexpod at 300 E. 39th St, Kansas City, MO 64111 and at the Juniper
